Introduce the topic of the paper and the thesis statement. (The thesis statement is almost always at the end of the introduction.) 2. State the facts of the case. 3. Prove the thesis with

your arguments. 4. Disprove your opponent's arguments. 5. End the essay. Explain the important points of your topic so that the audience can understand the paper's position. While eloquence is the goal, a student may write an effective argument essay simply by using good structure. Transitions create flow between sentences and paragraphs; they also allow the reader to follow the writer's train of thought.
